Heritage Days 2007

The 10th annual Montgomery County Heritage Days Weekend was the most successful ever—more than 15,000 visitors enjoyed the beautiful weather while visiting the 35 historic sites across the County that were open to celebrate our history. Some highlights of the weekend were:

- The hundreds of bicyclists who stopped at the Monocacy Aqueduct on their way west to inaugurate the completion of the Great Allegheny Passage bikeway from Washington D.C. to Pittsburgh via the C & O Canal and Cumberland.
- Over 260 participants of the hike along the Underground Railroad in the Quaker settlement of Sandy Spring who discovered just what so many had to do to make their way to freedom.
- The many who sat mesmerized at Sandy Spring Slave Museum when storyteller Diane Macklin shared the saga of how her great, great greatgrandmother came to Maryland from the west coast of Africa as a child
- The thousands who visited Glen Echo Park to enjoy activities throughout the Park, especially riding on the vintage Dentzel Carousel.

Update on Grants Maryland Heritage Areas Authority Supports HM

Heritage Montgomery received \$155, 425 for five local projects which were chosen by the Maryland Heritage Areas Authority/MHAA--(the state agency which partially funds Heritage Montgomery) for their proposals which will support County heritage activities in the coming year. Following are brief descriptions of the successful projects:

 A grant of \$50,000 was awarded to Montgomery County Park and Planning Commission to prepare for the restoration and adaptive reuse of the Woodlawn Barn in Sandy Spring as a multi-media interpretive visitors center for the Underground Railroad.

A non-capital grant of \$21,425 to the King Barn Dairy MOOseum in Germantown to provide visitors with an enhanced website and vibrant, hands-on exhibit and materials for an educational experience in an authentic dairy barn.

The Town of Poolesville received a \$50,000 grant to develop a Streetscape Concept Plan that will help preserve its small-town character, promote pedestrian access and

enhance the visitor experience of the Town as a gateway into the Farming History Cluster of the County's Heritage Areas

- The Montgomery County Park and Planning Commission will utilize a grant of \$19,000 to construct 19 visitor entrances and associated parking for the portion of the 25 mile Rachel Carson Greenway that lies within the County.
- The Heritage Tourism Alliance was granted \$15,000 to develop a PODcast Driving Tour of the Agricultural Reserve that will be based on the existing driving tour of Montgomery's Rural Heritage Byways but will expand the focus and attract larger, potential audiences through the use of up-to-date technology

These funds are made available to organizations and businesses that promote heritage tourism and economic development in our heritage areas. We look forward to visiting the MOOseum when it opens and to completing our PODcast driving tour so that many more will come to know our historic roots and rich heritage.

Mini-Grants Our Third Round of Mini-Grants

One of the most enjoyable and important actions that we take here at Heritage Montgomery is the awarding of our Minigrants to groups in the County that contribute to interpreting, promoting, preserving, researching or supporting our heritage and historic legacy. The Heritage Tourism Alliance has conducted this grant award program for the last two years. During that time we have distributed over \$24,000 to 17 project applicants.

These Mini-grants assist:

- Heritage related, non-profit organizations located in the County
- Privately-owned businesses located in a designated Heritage Area in the County
- Incorporated municipalities located in a designated Heritage Area in the County.

Applicants must match the requested amount with in-kind or cash donations.

In October, the Alliance awarded an additional \$17,500 in minigrants to the following recipients:

National Capital Trolley Museum, Silver Spring: \$1,000 for improved signage for the trolley cars

C & O Canal Association: \$2,400 for a new brochure on the lost towns on the Canal, featuring photographs of the towns at Monocacy Aqueduct and White's Ferry

The Latvian Museum, Rockville: \$500 for a brochure featuring the museum's collections

Montgomery Back-in-Time 4-H Club, Derwood: \$1,000 to fund two square dances at the Agricultural History Park

Montgomery Preservation, Inc., Silver Spring: \$1,500 for design of a new brochure highlighting historic Silver Spring

Upcounty sites also enjoyed a boom in attendance this year; Seneca Schoolhouse, St. Paul Community Church, the Clarksburg Historical Society at the General Store, and the Waters House saw a record number of visitors. Many were attracted to the Warren Historic Site, where the Garbo Gospel Choir performed, while hundreds came to Sugarloaf Mountain Vineyard and learned about the award-winning wines produced there. The B&O Railway Station in Silver Spring and the Historic "Fire Station # 1," featuring an acoustic blues trio, lured many visitors to appreciate their roles in the history of a very fast-growing area of our County.

Heritage Montgomery goes High Zech

Heritage Montgomery is poised to enter the 21st century world of technology with our PODcast Driving Tour of Montgomery Rural Heritage Byways. The development and completion of this tour is made possible by grants from the Maryland Heritage Areas Authority and the Arts and Humanities Council of Montgomery County. The PODcast will be based on an existing driving tour the Alliance designed but the new concept will allow those interested to access our audio-visual tour where and when they wish after downloading to an MP3 device such as an iPOD.

Visitors will have the convenience of starting and pausing the tour while viewing the featured sites, enjoying the audio tour as if a tour guide were accompanying them. We expect that the easier, expanded access to our tour will promote a wider appreciation of our history and heritage. We plan to expand the current driving tour now featured on our website and make the PODcast tour more comprehensive by incorporating additional detailed information on the featured areas together with appropriate visual images(photographs, maps etc)and audio soundtrack(narration and music). We at the Alliance are excited that this tour will be a model for other organizations in the County that wish to develop other thematic podcasts that highlight their own mission.

We finished recording the voiceover narration for our expanded video PODcast in mid-November and appropriate music and visual images are now being selected that will complement the narrative. We anticipate that it will be available for download from our website (and also for use as a promotional tool for County tourism) early in the new year.

Saint Paul's Community Church 14730 Sugarland Lane Poolesville, Maryland 301-330-3937

This historic African-American church was established by freed slaves after the emancipation. The church site was purchased on October 6, 1871 for the sum of \$25.00. The deed specified that the land would be used for religious worship, a school and a burial site for people of African descent. The current church was built in 1893 and is still in use. The cemetery contains graves of freed slaves; the earliest grave dates to 1871. In the 19th century the Sugarland Community had a population of 100. It was a self-contained community consisting of a school, a church (which also served as a community center and courtroom) and store. The community worked together to provide help for members of the church. The Sugarland Ethno-History Project was established and the goal is to create a museum where members of this historical community can document their genealogy from slavery to present day.
